### About Sustainable Development Goals

The Sustainable Development Goals (SDGs) are a universal call to action to end poverty, protect the planet and improve the lives and prospects of everyone everywhere. The 17 goals were adopted by all UN member states in 2015, as part of the 2030 Agenda for sustainable development which sets out a 15 year plan to achieve the goals.

In India, NITI Aayog is the nodal agency for coordinating and monitoring the Sustainable Development Goals. NITI Aayog has developed a framework of SDG India Index & Dashboard in 2018 to capture the progress made by states and union territories. Since then, it has become the primary tool to monitor the progress and achievements towards realising the 2030 Agenda.

The processes undertaken by Haryana towards the achievement of the SDGs began with the development of the SDG Vision 2030 document. Haryana has outlined its vision for 2030 as follows:- "We envisage Haryana as a vibrant, dynamic and resurgent unit of federal India. A state where farms overflow with produce; the wheels of industry grind uninterrupted; none feels deprived; people have a sense of fulfilment; the youth sense of pride, and women enjoy not only safety, security and equal opportunities but also feel empowered. Antyodaya, minimum government and maximum governance, and making the state a better place to live in, constitute the bedrock of our vision".

To achieve the SDGs, Haryana has established the Sustainable Development Goals Coordination Centre (SDGCC) in collaboration with the United Nations Development Programme (UNDP) India under Swarna Jayanti Haryana Institute for Fiscal Management (SJHIFM). The main aim of the SDGCC is to ensure that the state of Haryana is empowered, prepared and fully equipped with technical knowledge, capacity, resources and systems to implement and achieve the ambitious targets it has set for itself in SDG VISION 2030. It works with all stakeholders to operationalise SDGs within and outside the government, by helping them align their work with SDGs and by providing technical know-how, tools, systems, and resources. The SDGCC focusses on bringing in 'whole of government' approach through integrated planning and implementation of solutions for all State departments and localising the SDG Agenda at the District/Panchayat level by aligning their plans with SDGs. SDGCC also adopts 'whole of society' approach in achieving SDG 2030 Agenda by forging innovative partnerships with the private sector, civil societies and academia and building awareness and capacity of all stakeholders, including government officials, media, youth etc.

SDGCC Haryana has already delivered tools and knowledge products to government and departments for better monitoring and implementation of SDGs. For example Output-Outcome Framework Reports, Budget Allocation Reports, State Indicator Framework, Best Practice Case Study Booklets, SDG Alignment Reports for NGOs, CSR, Universities. It has also created various communication tools like website, social media accounts, best practices films, exhibition panels, posters, SDG Anthem audio/film, multi-level online quizzes. To catalyse the SDG localisation at district level. District SDG Profile booklets, District Budget Booklet for Aspirational District Nuh have been created. Activities related to system strengthening like budgetary exercise/ processes, capacity building and sensitisation of departments, Aatmanirbhar Bharat Tracker, mapping of SDG aligned budget in State's Online Budget Allocation Monitoring & Analysis System (OBAMAS), SDG First Networking Platform are some other tools created by SDGCC.


### Haryana SDG Status

Haryana Sustainable Development Goals Index 2020-21




NITI Aayog, a Government of India nodal agency for coordinating and monitoring of Sustainable Development Goals, has launched the SDG India Index & Dashboard 2020-21 on the theme of "Partnerships in the Decade of Action." This SDG India Index report is based on on 17 Goals, 70 Targets and 115 Indicators. In this report, India's composite score has shown improvement from 60 to 66, whereas Haryana's composite score increased by 10 points from 57 to 67. The rank of Haryana also improved by 4 levels to 14th, up from 18th rank in 2019-20. This 4 point jump in rank positions Haryana as the third best performing state in India.

Haryana has already taken numerous steps towards the achievement of SDGs and corresponding to that, Haryana became a Front Runner State in 2020-21 from being a Performer State last year. Haryana is the first state which has prepared a Vision 2030 document to achieve the SDG targets, and established the Sustainable Development Goals Coordination Centre at Swarna Jayanti Haryana Institute for Fiscal Management in collaboration with United Nations Development Programme (UNDP) India.




#### Overall Improvement in Composite Score from 2018-19 to 2020-21

In figure 1.1, Haryana's rank comparison for 2019-20 and 2020-21 and amongst different states is given. In figure 1.2, SDG wise composite score comparison of Haryana with India is given. As per figure 1.2, Haryana's composite score in 8 SDGs is above the composite score of India whereas in 7 SDGs, the composite score is below the national average.

The progress of Haryana in SDGs over a period of three years can be examined in the table below. In the year 2018-19, most of Haryana's SDGs were in the Performer category. In the following year in 2019-20, almost an equal number of SDGs fell into the categories of Front Runner and Aspirant. But in year 2020-21, a major change was seen in the performance SDG-1, SDG-11 and SDG-12 resulting in Haryana jumping straight into the Front Runner category from the Aspirant category in these SDGs.

Haryana became the Best State i.e. Achiever amongst all states of India in SDG-7 i.e. Affordable and Clean Energy.





For Haryana, 18% of the indicators are in the Achiever category and 42% are in the Front Runner category. But the area of concern for Haryana is 32% of indicators falling in the Aspirant and 8% in the Performer category. The majority of Aspirant indicators are under the SDG-5, SDG-8, SDG-4 and SDG-15 where more focused and targeted approach is required.



### Department Focused SDG Indicators

#### **Department Focused SDGs**

In NITI Aayog SDG India Index & Dashboard 2020-21, 110 indicators were selected for ranking and composite scores of different States and UT's of India. Out of 110 indicators, only 107 indicators were selected for the Haryana State indicator progress on SDGs. Two indicators of SDG-15 were left out due to merging of indicators and one from SDG-10 which is not associated with the state.

The methodology used for calculation and categorisation of indicator progress was done completely based on the NITI Aayog's methodology for positive and negative indicators. For positive Indicators, the formula used was as under:

$$x' = \frac{x - min(x)}{T(x) - min(x)} x100$$

where, x = raw data value min(x) = minimum observed value of the indicator in the dataset T(x) = target value for the indicator x' = normalised value after rescaling

#### For negative indicators formula used:

$$x' = \left[1 - \frac{x - T(x)}{max(x) - T(x)}\right] \times 100$$

where, x = raw data value max(x) = minimum observed value of the indicator in the dataset T(x) = target value for the indicator

x' = normalised value after rescaling

Categorisation was done on the basis of composite score into Aspirant (0-49), Performer (50-64), Front Runner (65-99) and Achiever (100) categories. All indicators were then mapped with departments according to the schemes and budget heads aligned to SDGs.

A detailed analysis of 21 major departments mapped along with 4 category of indicators and their budget expenditure is shared in the following pages:




